

## SAILING INSTRUCTIONS

**September 8-10, 2023** 

ORGANIZING AUTHORITY – University of Toledo Sailing Club (UTSC)
HOSTED BY – North Cape Yacht Club (NCYC)

## 1. RULES

- 1.1. This regatta will be governed by the current Racing Rules of Sailing of the United States Sailing Association, and by these Sailing Instructions.
- 1.2. All boat and crew are required to abide federal, state, and local laws, guidelines recommendations and restrictions regarding the COVID-19 virus, including but not limited to masking mandate and occupancy requirements for boats of various sizes.

## 2. CHANGES TO THE SAILING INSTRUCTIONS

2.1. Any changes to the sailing instructions will be posted before 0800 on the day it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.

## 3. COMMUNICATIONS WITH COMPETITORS

- 3.1. Notices to Competitors and scheduled protests will be posted on the official notice board.
- 3.2. The official notice board will be the window next to the front door of the club.
- 3.3. On the water, the race committee will make courtesy broadcasts to competitors on VHF Channel 71.
  - 3.3.1. The race committee (RC) may report all visual signals displayed by the RC and report OCS boats after the start on the courtesy channel. Information reported by the RC is provided as a courtesy to competitors, failure to hail her sail number, failure to hear such a hail, or the order in which boats are hailed will not be grounds for redress. This changes rule 62.1 (a).
- 3.4. From the warning signal of the first race of the day until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.





## 4. CODE OF CONDUCT

- 4.1. [DP] Competitors and support persons shall comply with reasonable requests from the race officials.
- 4.2. [DP] Competitors and support persons shall handle any equipment provided by the organizing authority with care, seamanship in accordance with any instruction for its use and without interfering with its functionality.

## 5. SIGNALS MADE ASHORE

5.1. Signals made ashore will be displayed from the flagstaff between the NCYC Clubhouse and the channel. Postponement is indicated by Code Flag "AP" accompanied by two sound signals.

The warning signal will be made not less than 30 minutes after the "AP" flag is lowered.

Abandonment is indicated by Code Flag "N" and three sound signals.

## Saturday

8.1. Racing for Saturday will consist of Buoy Racing and Windward/Leeward races with a windward offset and a Leeward gate. Below are the course options for Saturday 1<sup>st</sup> race






## Buoy Races (Starting at Center Mark) – The course will be displayed on the RC boat

2	Center - North - West - Center
3	Center - South - East - Center
4	Center - South - West - Center
5	Center - East - South - Center
6	Center - East - North - Center
7	Center - West - South - Center
8	Center - West - North - Center
9	Center - North - South - Center
10	Center - South - North - Center
11	Center - West - East - Center
12	Center - East - West - Center

## Windward/Leeward - The course will be displayed on the RC boat

Course	Legs
1 (2 Laps)	Start-Windward (Closed Gate)-Leeward-Windward-Leeward
	(Open Gate)-Finish
2 (1 Lap)	Start-Windward (Open Gate)-Leeward (Open Gate)-Finish

# 8.2 Marks will be as follows – TBD (NCYC Marks, West Marine Marks, or Possible MarkSetBot)







## Sunday (Sundays race course will posted on the official notice board on Saturday night)

8.3. The Race Committee will identify the course direction with RED flag (Marks to Port) or GREEN flag (Marks to Starboard). The course number will be indicated by panels with Yellow numbers on a Black background.

## 9. START AND FINISH

- 9.1 **Saturday 1**<sup>st</sup> race: Will be between the NCYC Center mark, and the orange flag on the R/C boat. The mark is located approximately 1 ½ NM's east of the NCYC channel entry.
- 9.2 **Saturday Windward/Leeward:** Will be between the Yellow inflatable and the orange flag on the R/C boat.
- 9.3 **Sunday Long distance race** will be between the NCYC West mark, and the orange flag on the R/C boat. The mark is located approximately 1 ½ NM's east of the NCYC channel entry.

## 10. RECALLS

10.1 Recalls will be made in accordance with Rule 29 The RC may hail yachts that break RRS 29 on Channel 71. Failure to hear the hail is not grounds for redress.

## 11. PROTEST

11.1 Competitors shall notify the Race Committee after finishing, of any intent to file. Written protests shall be delivered to the NCYC Race Committee in the YA scoring room within 1 hour after the Race Committee finishes docking their boat. Hearings will be held as soon as possible after the hour limit has expired.

## 12. SAFETY REGULATIONS

- 12.1. Prior to the first race each day, each boat shall check-in by:
  - 12.1.1. Sailing astern of the RC signal boat and hail her sail number,
  - 12.1.2. The RC will acknowledge the hail.
    - 12.2. A boat that does not intend to start a subsequent race shall notify the RC at the first reasonable opportunity.
    - 12.3. A yacht that retires shall notify the Race Committee before leaving the racing area. If that is not possible, the yacht shall notify NCYC as soon as possible. The club monitors VHF channel 16. Club Telephone: (734) 242-5081.
    - 12.4. RRS 40.1 shall apply from the time a boat departs the dock until they return to the dock. This applies only to the competitors on board and excludes the scrutineers and coaches.

## 13. SUPPLIED BOATS

13.1. Competitors shall report any damage or loss of equipment, however slight, to the organizing authority's representative immediately after securing the boat ashore. The penalty for breaking this instruction, unless the protest is satisfied that the competitor made a determined effort to comply, is disqualification from the race most recently sailed.





## **14. RISK STATEMENT**

14.1. RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue to race is hers alone." By participating in this event, each competitor agrees to acknowledge that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform, and fatigue resulting in an increased risk of injury. Inherent to the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia, or other causes.

14.2. Competitors participate in the regatta entirely at their own risk. See RRS 3, Decision to Race. The race organizers (OA, Race Committee, Protest Committee, sponsors, or any other organization or official) will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. By participating in this race, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this regatta to the fullest extent permitted by law.
